Product:

- Lean Management: Medifab reduces the amount of raw materials used and manufactures according to Lean principles which eliminate waste in the manufacturing processes.
- Reusability: Medifab believes in reusability and reissuability where possible. Our products are designed for durability. Medifab's procurement team only select products and components of the highest quality, so that our customers gain years of use out of their Medifab products.
- Charitable Support: Old and obsolete product are donated where possible to impoverished communities such as the Pacific Islands (made possible by New Zealand therapists who facilitate workshops in countries such as Samoa). See examples here.

Planet:

- Environmental Principles: Ensure that Medifab is run on sound environmental principles, including reduction of emissions, energy conservation and good waste management practices.
- Legal: Ensure compliance with any legislation that promotes sustainability, in each of the countries which Medifab operates in.
- Our Impact: Medifab will seek to reduce our carbon footprint and monitor operational resource use. We will seek to reduce energy consumption by purchasing energy efficient equipment and good housekeeping.
- Recycling: We will endeavour to maximise material reuse and recycling, and actively promote methods which
 minimise waste. Printing is avoided where electronic copies suffice, toner cartridges are recycled through the
 print providers and paper is recycled. Metals are recycled.

Medifab are committed to responsibly growing the business while continually monitoring, managing and optimising operational activities to ensure there are no adverse impacts on local environment, and the communities in which we operate.
